PARISH COUNCIL MEETING

Minutes of the meeting held at The Village Hall, Gisleham on Monday 16th September 2019 at 7.30 pm

24. Declarations of pecuniary or other interest relevant to items on the agenda. No interests declared.

25. Minutes of the Council meeting held on 8th July 2019:

26. Report from Suffolk County Councillor

Councillor M Ladd reported that Suffolk County Council Planning Committee approved the application for the car park at Carlton Colville Primary school on 17th July 2019. Although there had been an objection to the scheme from Sport England, the application was not 'called in' and final approval was issued on 10th September 2019. Some further highways conditions are being addressed. A contractor has been appointed and it is hoped work on the accesses will be carried out during the October school half-term holiday.

The Parish Council had received a letter from a local resident requesting on-road parking restrictions during school periods. Councillor M Ladd has requested the necessary Traffic Order and the situation will be re-assessed when the car park has been completed.

27. Report from East Suffolk Councillors:

Councillor J Ceresa had advised that Community Enabling Budgets are being considered and that workshops will be arranged to consider expenditure priorities.

Councillor C Rivett notified that East Suffolk Council were prepared to support a First Light Festival in 2020, providing further outside funding was secured.

28. Questions from Parishioners:

- 28.01 The footpath on Snab Hill is becoming overgrown. Could this be cleared? The Clerk will issue request to County Highways.
- 28.02 The hedge at the front of The Paddocks is overgrown and becoming a hazard.

29.01 Carlton Colville Neighbourhood Plan:

29.03 Provision of Dog Waste Bins in Village:

The dog waste bins have been delivered.

Agreed that one should be located at the end of the footpath at Snab Hill, opposite Black Street junction, and the other at Dale End play area.

29.04 Access to Gateway Retail Park:

Concerns have been expressed about the location of the advertising totem at the entrance to the carpark obscuring visibility on exit.

This is being addressed by East Suffolk Council. One solution may be to remove the lower two panels.
